SHIFTING ORDER

09 AUG 2024

WHEREAS the recognition was granted to the institution namely **Kirti College of Education, VPO. Anayat, Tehsil-Gohana, District-Sonipat, Haryana** for **B.Ed.** course with an annual intake of **100 students (two basic units of 50 students each)** vide order No. **NRC/NCTE/F-7/HR-854/32191** dated **08.11.2007** and Revised Order as per NCTE Regulation 2014 was issued to the institution for **B.Ed.** course of two years duration with an annual intake of two units vide order No. **F. NO. /NRC/NCTE/HR-Common Order/ 2015/ 114507** dated. **06.06.2015**.

2. **AND WHEREAS**, the institution submitted application for shifting of premises vide letter dated **13.09.2022** received in NRC office on **14.09.2022**.

3. **AND WHEREAS**, the matter was placed before NRC in its **390th meeting held on 20th & 23rd January 2023** in light of order dated **16.01.2023** passed in **W.P.C. No. 82/2023** and the NRC decided to issue Show Cause Notice u/s 17 of the NCTE Act, 1993. Accordingly, SCN u/s 17 was issued to the institution on **14.02.2023**.

4. **AND WHEREAS**, the matter was considered by NRC in its **399th meeting held on 26th May 2023** in light of order dated **17.04.2023** passed in **W.P.C. No. 1963/2023** and the committee decided that **Final Show Cause Notice u/s 17 of NCTE 1993 to be issued to the institution only for the shifting of premises**.

Accordingly, Final Show Cause Notice u/s 17 was issued to the institution on **17.06.2023** and Institution has submitted its reply vide letter dated **27.06.2023** and received in NRC office on **04.07.2023**.

5. **AND WHEREAS**, the matter was placed before NRC in its **408th meeting held on 16th & 17th August 2023** and the committee decided that **Shifting Application of the institution be refused on the following grounds:**

- The institution has not submitted **NOC from State Govt. for shifting of premises.**
- The institution has not submitted any proof/evidence to prove that it is the composite institution as clause 2(b) of NCTE Regulation 2014.

Accordingly, Refusal Order was issued to the institution on **30.08.2023**.

6. **AND WHEREAS**, the institution preferred an appeal before the Council. **The Appellate Authority vide order dated 10.10.2023 remand back the case of Kirti College of Education Anayat Gohana, Sonipat, Haryana-131301** to the NRC, NCTE for necessary action.

7. **AND WHEREAS**, the matter was again considered in its **415th** meeting of NRC held on **20th to 21st November 2023** and committee decided that **Show Cause Notice was issued to the institution.**

Accordingly, Show Cause Notice was issued to the institution on **01.12.2023** and Institution has submitted **reply of Show Cause Notice vide letter dated 27.12.2023, 02.01.2024, 13.02.2023, 30.12.2023, 10.01.2024** and **received in NRC office on 02.01.2024 and 11.01.2024.**

8. **AND WHEREAS**, the matter was placed before the NRC in its **418th Meeting held on 23rd and 24th January 2024** and the committee decided **to constitute the Visiting Team for conduct of Inspection of the institution of its newly constructed premises for shifting as per provisions of clause 8(9) of NCE Regulations, 2014.**

Accordingly, the inspection of the institution **for shifting of premises** was constituted on **06.02.2024** and the report of the inspection of the institution was uploaded by VT Members on **06.02.2024.**

9. **AND WHEREAS**, the matter was again placed before the NRC in its **420th meeting held on 01st & 02nd April 2024** and Committee decided as under:

“The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.

The Committee considered the online Virtual Inspection Report of the institution and decided that the First Show Cause Notice be issued to the institution based on the following grounds:

- The institution is required to submit a copy of the Land Mutation certificate.
- The institution is required to submit certificate to the effect that the institution building is friendly to differently abled persons, issued by Competent Government Authority.
- The institution has not provided the drinking water facilities at first floor.
- Toilets are not connected to the main building and are located in open area. Also, the toilets are inadequate in numbers.
- Labs are inadequate in numbers and not as per NCTE norms.
- Library cum reading room lacks professional management.
- The institution to submit the latest faculty list duly approved by the affiliating body and the geo tagged photographs of the institution.

In view of the above, the Committee decided that First Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 21 days from the date of issue of show cause notice.”

Accordingly, Institution has submitted **reply of First Show Cause Notice based on uploaded minutes on the website vide letter dated 15.04.2024** and received in NRC office on **26.04.2024.**

10. **AND WHEREAS**, the matter was placed before NRC in its 423rd Meeting held on 15th, July 2024 and Committee decided as under:




